2020-21 Annual Tuition, Childcare Fees, and Payment Options Academic Year: August 24, 2020–June 4, 2021

Annual Tuition Payments

Your tuition is an annual fee. It is expected that you will pay tuition in full by the due date, **August 1, 2020.**

For new students starting September–May: Tuition for students who start mid-year is prorated based on the number of days remaining in the school year. Full payment is due one week before your student's first day of school. You will receive a \$150 discount for paying your tuition in full. This discount applies to tuition only.

You will receive a \$150 annual discount per family for paying your tuition in full. This discount applies to tuition only.

Installment Payment Plan

Your tuition is an annual fee. The Installment Payment Plan is offered for families who prefer to pay the annual tuition in **10 equal installments.**

Installment payments are due by the 1st of each month, beginning August 1, 2020 and ending May 1, 2021.

For new students starting September–May: Installment payments will begin the month in which your student starts and will end May 1, 2021. Payment amounts will be divided evenly across the number of months remaining until May 1, 2021.

A \$55 **annual** fee per family applies if you select the 10-installment payment plan for tuition or childcare.

Home Learning Per Diem Credit

In the event that MIR is required to shelter in place and/or close our campus and shift to Montessori Home Learning during the 2020-2021 school year, MIR will apply a credit to all accounts on a **per diem** basis up to, but not to exceed, 40 Home Learning days. The credit applied will be based on the following scale:

- Toddler: 50% of the daily calculated rate
- Primary: 20% of the daily calculated rate
- Elementary: 15% of the daily calculated rate

The credit will be calculated and applied at the end of each stay-at-home order that is put into place August 24, 2020–June 4, 2021.

Sibling Discounts

The following sibling discounts are offered on tuition only. The sibling discount is offered regardless of whether you pay annually or choose the installment payment plan.

- 3% per child for two students enrolled at MIR
- 8% per child for three or more students enrolled at MIR

Payment Policy

Prompt payments are a prerequisite to the continued enrollment of your student.

- Annual payments and Installment 1 of the Installment Payment Plan are due by August 1, 2020.
- All Mid-Year Annual payments are due one week before the student's first day of school.
- All installment payments are due by the established due date. A fee will be assessed by TADS for late payments.

Incidentals (fees for single-day use childcare with or without 24-hour notice, failure to sign in/sign out, Student Services, and other miscellaneous fees) are billed monthly.

A \$35 late fee will be assessed if payments are received after the established due date.

Accounts are considered delinquent when 30 days past due. Delinquent accounts will be referred to the Finance Committee of the MIR Board of Trustees for collection processing and may result in student dismissal and delay of student records. Student’s account balance must be current to enroll for a new term. In the event the account falls delinquent after the student is enrolled for a new term, the enrollment fee and class placement may be forfeited.

Accepted forms of payment for tuition and incidentals are electronic check (EFT), credit/debit card, or check. All payments are made via TADS. Checks should be made out to and mailed to TADS. Sign into your account for instructions. *Additional fees will be applied to all payments paid via credit/debit card or electronic check.*

Tuition Rates and AM/PM Childcare Fees Per Program

Rates and fees listed are per year. Children must be enrolled in our programs to sign up for before- or after-school childcare. **If your child changes programs mid-year**, your new program tuition is prorated based on the number of days remaining in the school year.

Financial Aid Policy

Financial assistance is available to current families who have been enrolled for a year or more.

Assistance is limited to families facing unexpected, sudden financial challenges. The aid provides partial tuition assistance to help keep their students enrolled at MIR so that the children do not have to face the additional stress of a change in schools.

To be able to serve as many families as possible, funds are not available long term. **Current families should contact the office for an application packet.**
